On behalf of my child, \_\_\_\_\_, I voluntarily make and grant this Waiver of Liability and Assumption of Risk in favor of **FOWLER FIREARMS & GUN RANGE LLC**, (Seller) as partial consideration and in addition to monies paid to Seller for the opportunity to use the gun range, facilities, equipment, materials and/or other assets of Seller; and/or to receive assistance, training, guidance, tutelage and/or instruction from the personnel of Seller; and/or to engage in the activities, events, sports, festivities and/or gatherings sponsored by Seller: on behalf of my said child, I do hereby waive and release **FOWLER FIREARMS & GUN RANGE L.L.C.**, and all its employees from liability for any and all claims, whether in contract or of personal injury, bodily injury, property damage, damages, losses and/or death suffered by my said child that may arise from my aforementioned use and/or receipt, as I understand and recognize that there are certain risks, dangers and perils connected with such use and/or receipt, which I hereby acknowledge have been fully explained to me and which I fully understand, and which, on behalf of my said child, I nevertheless accept, assume and undertake after inquiry and investigation of extent, duration, and completeness wholly satisfactory and acceptable to me. I further agree to use my best judgment in my child's undertaking these activities, use and/or receipt and I will carefully supervise and to cause my said child to faithfully adhere to all safety rules, instructions and recommendations, whether oral or written. I hereby certify that I am a competent adult legally authorized to assume, on behalf of my said child these risks, being under no compulsion or duress to do so. I hereby waive any liability you may incur to my said child because of your ownership or control of a dangerous instrumentality which is the source of injury to my said child. I further waive any liability you may have to my said child for injury resulting from your simple negligence and for any obligation you may have to reimburse me for my liability or my child's liability to others, regardless of cause. # RANGE RULES

1. Always treat firearms as if they are loaded.
2. Firearms will be unloaded prior to entering, and leaving the range with slides locked back, and cylinders kept open.
3. Never put your finger on the trigger until you are ready to shoot.
4. Always be certain of your target and backstop before firing.
5. All shooters must be wearing Ear & Eye Protection before entering the range.
6. Firearms will stay in the assigned shooting lane at all times.
7. A maximum of two shooters allowed per lane, observers are not allowed in the range.
8. Firearms on the firing line will be pointed directly down-range at all times.
9. Do not use booth dividers for barricade shooting, or as a gun support while Shooting.
10. Rapid fire is only allowed with prior permission.
11. Should a misfire or other malfunction occur, keep the firearm pointed downrange and get help from a staff member.
12. All brass must be swept up and deposited in the marked container.
13. Shooters who deliberately shoot the range baffles, supports, or target retrieval system will be charged for the damage and barred from the range.
14. Rental firearms will always be returned in the tray provided, and in a safe condition.
15. Only ammunition purchased from Fowler Firearms can be used in our range.
16. Food, drink, gum, and tobacco products will not be permitted in the range.
17. Never move forward of the firing line. If anything falls forward ask a staff member for assistance.
18. Accidental discharges, damages, or injuries, must be reported to a staff member immediately, no matter how minor they may seem.
19. Anyone believed to be under the influence of alcohol or drugs will be refused use of the range, and asked to leave the premises immediately.
20. Shooters under the age of 21, must be accompanied by an adult while on the range.
21. Initial the top right corner of this page to verify that you have read the above rules.

**If any of the above rules are violated, you will be asked to leave the range.**
